I. BRIEF INTRODUCTION TO THE PROJECT

The overall objective of the EURASIA project is to introduce high quality European Studies programs in universities in India and China and to enhance the visibility of EU-related topics in the through the creation of professional academic networks. The project aims to bring positive and long-term impact to the partner higher education institutions through concerted and focused capacity-building targeting students, faculty and staff.

EURASIA is a unique initiative with a significant potential to strengthen the international cooperation and dialogue between the European partners and the higher education institutions in India and China. The 3 year project, which has a total budget of 760, 239 EUR, is funded by the Key Action Capacity Building in Higher Education, Erasmus + Programme. The Project Consortium (hereinafter the “Consortium”) comprises as follows:

II. PROJECT OUTPUTS

The objective of the Exploitation plan is to provide a structured approach in ensuring that the project results are successfully disseminated and that a wider impact is achieved and potentially a significant systemic influence on the participating higher education institutions in terms of curriculum and course development, building capacity, reaching out at universities and stakeholders in each partner country, multiplication efforts and outreach of student population. It also aims at clearly describing the exploitation approach and at ensuring that the proposed measures to exploit the project results are potentially effective. The exploitation plan should also emphasize how the outputs and impact of EURASIA will be sustained beyond the project period. The exploitation plan is an open document to be gradually developed in the process of the project implementation in its main phases. Regarding its gradual development the following main stages are identified:

- Initial stage at the beginning of the project implementation based on input from the project application, experts' feedback and the selection process and discussions at the first project partnership meeting (First draft).
- Intermediate stage after the second round of trainings based on the Partner universities' Wish Lists, compiled in the process of training and analysis of the potential for curriculum development at the home universities (Second draft).
- Interim report stage to feed into the interim technical report to the Executive Agency containing an approved by the home universities list of courses to be developed and accredited (Third draft).
- Final stage approved by the project steering committee during the piloting stage in academic year 2019-2020 based on the initial results and the proved potential of the developed and accredited courses (Final draft).

The final draft is the main document containing indicators of success for the project implementation, exploitation of the project results and the project sustainability justification.

Since the Project takes capacity building to the next stage by focusing on “revitalization”, it aims to create a robust set of ES courses that will become a foundation for a deeper understanding of the EU. The fundamental objective is to have an informed and meaningful participation in EU-India and EU-China relations. Mindful of this goal, the EP has created a framework for the design and delivery of the ES courses in the partner institutions, dissemination of the outputs of ES teaching and research in beneficiary institutions and outside of them, and to ensure that the project outcomes continue to influence and shape EU-India and EU-China relations.

The framework created by the EP for project execution also ensures that continuity from one phase of the project to another phase expands the scope of the project. Such an expansion will contribute to the sustainability of the project.

Primarily, the project will proceed through three phases of execution:

- A. Training**
- B. Dissemination**
- C. Extension**

A. Training (2017-2019)

1. The Pre-training Phase

As part of fulfilling the primary goal of the Project, the strengths, current expertise, and available resources of the beneficiaries have been identified (listed in D1.2 “Curricula Database” and in D1.5 “Report on available projects in the field”). Based on the existing approach to European Studies (ES) of their respective institutions, the beneficiaries proposed courses on ES which in their view can enhance their institutional capacity to enter into larger collaborations with the EU and to a certain extent expand the horizons of the strategic interest of the respective State towards the EU.

2. The Training Phase

Based on the inputs provided by the beneficiaries, the three hosting partners—SU, JU, and UNICT—have designed training programmes for the beneficiaries. The training programmes are to be held at UNICT from 21 October 2018 to 1 November 2018, at SU from 3 December 2018 to 14 December 2018, and at JU from 20 January to 3 February 2019.

The training programme is bifurcated into general training and specialized training. The first round of training at UNICT, SU, and JU will be general in nature. A second round will later on follow in the same universities based on the nature of the courses proposed by the faculty and expertise available.

First Round of Trainings

The first round of training programmes are designed mindful of the benefits of generality—the central idea is to provide the participants an EU imagination and an empathy to ES. The programmes primarily will focus on the possibilities of ES teaching, elements of epistemology and pedagogy of ES, possibilities of academic mobility under ERASMUS, syllabus designing, comparative possibilities of ES, and introduction to the EU and the Bologna Process. The



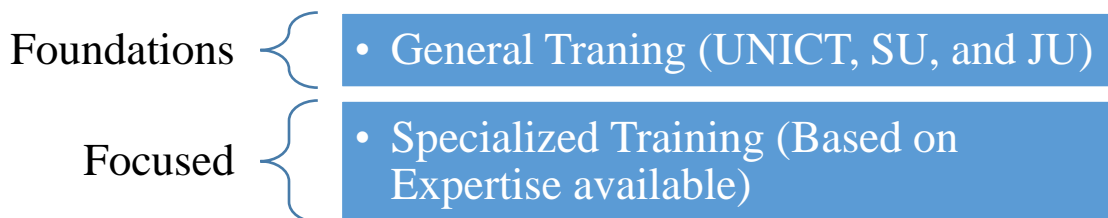
philosophy of the Training Sessions is to provide the participants a sense of the foundations of EU and the role of ES in advancing EU mobility and its foreign

relations, particularly EU-India and EU-China collaborations. The said generality will help homogenize the foundations of all the various ES courses that have been proposed by the participants.

The introduction to the Bologna Process will help the participants develop awareness of the essentiality of the spirit of the Bologna Process in ES. This will help avoid the ES courses to be offered in Indian and Chinese universities from being subject to local imaginations. The idea, however, is not to defy local imaginations, but to create among the participants an openness to the evolution of ES; rather than setting standards that less suit the spirit of ES. The execution and delivery of the courses, however, are left to the imaginations of beneficiary universities based on their programme and curricular structure.

The Second Round of Training

The training phase will further continue to specialized training. Each participant from the beneficiary institutions will get the opportunity for specialized training. The specialized training will be provided by UNICT, SU, and JU. Since participants will be attending the general training sessions having identified courses to be taught in their respective home institutions, they will be able to identify the possible collaborations (resource persons and institutions). EURASIA project coordinators at the beneficiary institutions can also help participants to identify collaborations for specialized training. The trainer institutions will host the trainees for a period of upto 5 days. The nature of the specialized training in a trainer university will be mutually agreed on and decided by the trainer institute and the trainee.



The main objectives of the training phase include:

- Mobility of instructors and ideas on various areas of ES
- Empower instructors to provide advanced courses on ES in their respective universities
- Create expert points-of-contact for instructors for the delivery of ES courses
- Provide inputs to participants on curriculum development for ES courses
- Obtain input from experts in a given area of ES
- Collaborative research and teaching
- Enhanced access to ES data resources through online platforms
- Create opportunities for instructors to interact with other instructors of ES courses for enhanced knowledge sharing

- Provide opportunities to explore inter-university partnership in teaching ES among beneficiary universities

B. Dissemination Phase (2018-2019)

1. The Scope of the Dissemination Phase

During this phase, the communication channels—the web portal and the data bank—will be launched and made available through password access to all instructors. The portal will have interfaces for data retrieval, blogs, multimedia uploads, and live chat. The portal will be the running aid when the courses, which have benefitted from the inputs from the training programmes, will be floated in the beneficiary institutions. During the dissemination phase, communication activities will be commenced in order to maximize the visibility to target groups, stakeholders and multipliers.

2. The Dissemination

The primary deliverable during this phase will be the ES courses in the beneficiary institutions. The courses will be situated within the course-grid e.g., as a compulsory course, elective course, seminar, clinic, etc. and credit structure of the beneficiary institution. The courses can be offered in Fall 2018 or Spring 2019.

Monitoring and Reporting Procedures: The EURASIA Managers in the beneficiary university will be responsible for monitoring the progress of the courses. They will also be responsible for the submission of the course completion reports and other outputs of the course to EURASIA.

Outputs: Outputs of the ES instruction may vary from beneficiary to beneficiary. Some possible outcomes can be:

- “ES Track”, through the ES courses, leading to a certificate/diploma programme in ES—the beneficiary institution will be responsible for designing the track, e.g., the number of courses to be taken to become eligible for the certificate/diploma, the sequence in which the courses will have to be taken, if any, prerequisites, if any etc.
- A uniform curricula and pedagogy for the ES courses

- Integration of training outputs into the existing philosophy of ES Studies in the beneficiary institution
- Teacher-to-teacher collaboration between two beneficiary or a beneficiary and training institution on areas of mutual interest

Exchange visits

As preparation for the dissemination, there will be exchange visits by the beneficiary institutions to discuss the best practices and best possibilities for conducting the courses. Although delivery of the courses will greatly depend on the nature of the institutions and the academic structure thereof, mutual exchange of ideas will help beneficiary institutions make best use of the capacity built through the training programmes. The visits will also help beneficiary institutions understand the framework in each other's institution and to understand from each other how to optimally use the frameworks to deliver the courses. These visits will provide a platform for cooperation and collaboration between the two partner-country universities with regard to curriculum development and accredited courses in ES.

Dissemination Conferences

Towards the end of the dissemination phase the entire work of the project will be reviewed through a review meeting in India and then through three dissemination conferences in Bulgaria, India and China.

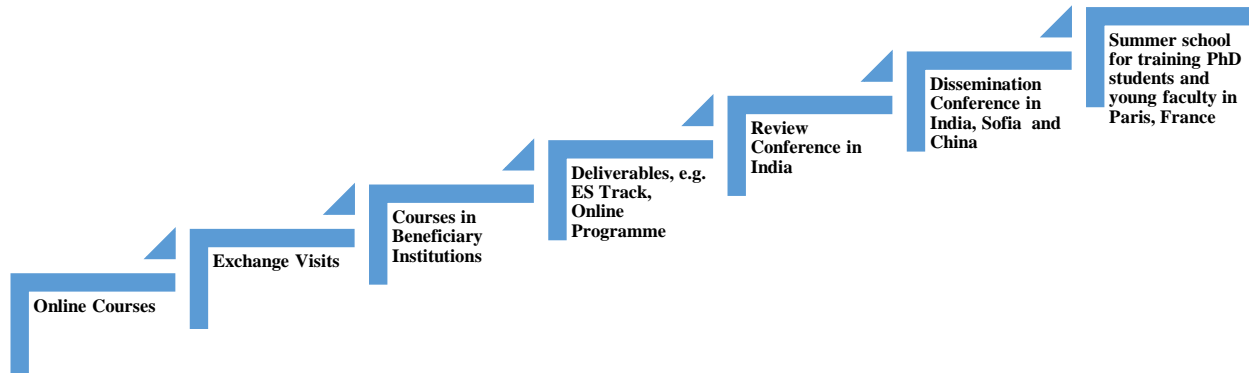
Online Courses

During the later stage of the training phase—that is, after the completion of the general training—and before the commencement of the actual dissemination phase, a set of online courses will be developed and offered by EURASIA through the customized web-platform. The courses will be general in nature, making use of the general training completed. The courses will be prepared for self-access and each of them will lead to the award of 0,5 ECTS credits (15 academic hours) each. There are ten online courses altogether under the five main agreed topics (See Annex 3).

Instructors for the courses will be drawn on the participants from the partner institutions who have undergone training and also from outside the EURASIA. The framework within which these online courses will be offered and the modalities for offering them will be developed by EURASIA in consultation with other partners of the consortium.

C. Extension Phase (2019-2020)

1. Scope of the Extension Phase

The extension phase will primarily focus on outreach. The outputs of the project will reach the stakeholders during this phase. Partners of the consortium will maximize the possibilities of reaching out to the stakeholders and decision-makers. The dissemination conferences in India and China will be a medium for outreach. The phase will also explore possibilities for the extension of the project to a stage II of EURASIA.

2. The Extension Phase

Extension within Beneficiary Countries (transferability)

During the extension phase, the beneficiary institutions will explore the possibility of reaching out to other institutions—academic, governmental, and non-governmental, in their respective countries who have interest in ES. Mapping of interested institutions will be carried out country



wise. Interest-mapping will be primarily done by the project managers of the beneficiary institutions. In mapping the interest, project managers will look for “capacity” to build, which

may be in the form of related courses or programmes (e.g, a graduate programme in international relations or geopolitics), event and activities that evince an interest in cross-cultural interactions, and demonstrated research in the form of policy papers or reports. The outreach will be done in the form of guest lectures, workshops, capacity building programmes, and consultancies in/to interested institutions. Certificate and diploma courses (outside the ES track) for students and professionals of interested institutions will also be offered by the beneficiary institutions.

Research Outputs

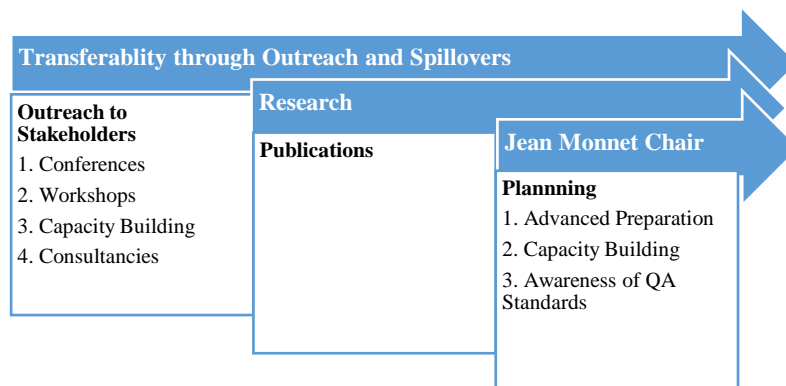
During the extension phase the participants in the consortium will engage in individually or collaboratively for publications. They will largely become the resource materials for the Project at the execution phase. That is when the Project engages in outreach and further capacity-building of interested institutions in the beneficiary states.

Jean Monnet Chair

The application for the Jean Monnet Chair will depend on the capacity building at the beneficiary institutions. Focus will be given on this possibility right during the dissemination phase by the beneficiary institutions. For this, the beneficiary institutions must ensure that the courses are drawn on diverse aspects of EU and strands of ES, creating multidisciplinary possibilities.

EURASIA managers in the beneficiary institutions should give thought on the possibility of an application for Jean Monnet Chair while organizing the courses and other activities during the dissemination phase. They should also familiarize themselves with the quality assurance standards employed by the assessors against an application for a Jean Monnet Chair. Inputs for such planning and preparations will be shared during the exchange visits by the beneficiary institutions. EURASIA will provide constant advice and guidance to the project managers in the beneficiary institutions.
