Project Summary

The overall objective of the EURASIA project is to introduce high quality European Studies programs in universities in India and China and to enhance the visibility of EU-related topics through the creation of professional academic networks. The project aims to bring positive and long-term impact to higher education institutions in China and India through concerted and focused capacity-building for faculty and staff. EURASIA is a unique initiative with a significant potential to strengthen the international cooperation and dialogue between the European partners and the higher education institutions in India and China.

Project Objectives

The EURASIA project aims to achieve the following objectives:

- 1. To contribute to capacity building in India and China in the field of European studies that can effectively enhance the EU-India and EU-China cooperation and dialogue as articulated in the 2016 EU Global Strategy in a Globalizing World.
- 2. To respond to the partner institutions' needs for new education and training modules in EU studies and to improve already established BA and MA level programs in EU related subjects
- 3. To strengthen the internationalization of education in the participating universities through the establishment of new networks of researchers and faculty.





- 4. To encourage intercultural communication between countries and regions.
- 5. To improve the competences and skills of faculty in partner institutions to deliver quality undergraduate and graduate level education in EU studies.
- 6. To provide faculty and young researchers in the partner universities in India and China with innovative opportunities for training, mobility and learning exchange.

Expected Results

- 1. Improved quality of teaching and learning of European studies in the partner universities.
- 2. New curriculum development and courses in EU studies.
- 3. Introduce modern methodologies for teaching and training through the use of digital technology.
- 4. Enhanced student enrollment in European studies at partner universities.
- 5. Promoted academic people-to-people contacts, cooperation and joint program delivery through faculty training, teaching and research opportunities between Programme and Partner countries
- 6. Fostered regional cooperation in education between partner universities in China and India.

Section One: Document Description and Main Research Findings

This document presents the findings of research done in WP Preparation; it offers a collection and description of courses and curricula in European Studies currently taught in the partner universities in China and India (Beijing Foreign Studies University – BFSU, Guangdong University of Foreign Studies - GDUFS, Symbiosis Law School – SLSP, and Jindal Global University – JGU). As described in the Work package, the research conducted forms a key element of the analysis of available resources and capacity for teaching at the partner institutions. The information was gathered during the exploratory visits to partner universities and through desk research and input from the EURASIA partners (using the Course description template in Annex I below).

Mapping the type and number of courses offered at the partner universities (either separately or as part of an EU Studies program) provides a good basis for comparing the existing expertise and core areas of interest within the EURASIA consortium. Drawing upon this stock of knowledge, project partners will jointly design the subsequent training programs for faculty members and will begin the development of course modules to be accredited and introduced in the Chinese and Indian universities.

General observations

The courses described below indicate that there is a growing interest in introducing European studies, and in general, a European dimension in higher education in the Chinese and Indian universities, which correlates also with the rising interest of students and faculty in the past ten years to study and do research in Europe (see D1.5 EU-funded projects in India and China). This trend aligns with the universities' own strategic priorities for internationalization and attracting





more foreign students as well as with major political and policy developments (for example, the recent initiative of the Chinese government *One Belt, One Road*, the framework decisions of the EU-India Summits, etc.) Since the scope of the work package and the study done are limited to the four partner universities, this document does not allow for a comprehensive analysis of the scale of European studies programs in Asian higher education institutions. Nevertheless it is possible to outline some similarities in the objectives of the European programs offered and competencies that students are expected to acquire in completing their studies. A few main conclusions can be drawn:

- Notably, the Anglo-Saxon Bachelors-Masters model for European studies is adopted by all
 partner universities (GDUFS also offers doctorate level courses). However, the EURASIA
 partners are yet to develop and introduce a full-fledged European studies/EU studies
 program.
- There is no clear definition or distinction between European studies and EU studies; neither of the partner universities has an independent European Union program.
- Partners have bilateral cooperation agreements to develop or expand existing European studies programs (e.g. BFSU's Nordic studies program). It is important to take into account the competition with other area studies that an EU studies program may face in attracting students.
- Financial and human resources are often limited for European studies; at GDUFS and BFSU courses on ES/EU related topics are taught by faculty from different departments.

Several topics deserve a more detailed discussion, as follows:

1. **Departments hosting European studies programs**: Partner universities have either established centers / schools for European studies or are offering separate courses cross-listed with departments for foreign language studies or international relations. The particular choice has to do with the university's main education policy and focus but also with the fact that sometimes the host center does not have faculty prepared to teach the respective courses. For example, BFSU offers ES-related courses in the School of European Languages and Cultures; the university is currently introducing BA elective courses in EU Law and Economy and courses will be taught from the respective departments of Law and Economy. The Symbiosis Law School-Pune also offers components of European Studies and language courses in French, German and Spanish across its various institutes of the Faculty such as: Law; Management; Media, Communication and Design; Humanities and Social Sciences. Some of the courses are designed as part of past or ongoing bilateral cooperation agreements between partner universities





and European universities or Erasmus Mundus Joint Degree projects (for example, a course on Nordic countries and the EU at BFSU).


2. **Thematic scope**: Overall, the courses and existing programs aim to provide comprehensive knowledge of contemporary Europe focusing on historical, political and cultural aspects. Courses offered fall into four main groups: EU History, Culture and Society; Law and International Relations; Business and Economies; European Union topics. Some courses take an interdisciplinary perspective, raising important questions about Europe's integration process from a legal, political, and economic point of view. Other courses provide a deeper consideration of the EU's policy-making process and principles, and the Union's ongoing attempts to formulate common policies in the economic and cultural fields, in the justice and security areas, etc. Many courses seek to explore current political ideas and issues, with an emphasis on the role of both European and Chinese or Indian actors in the process (e.g., seminars on China-EU issues offered at GDUSF). The courses and programs of Symbiosis Law School - Pune, including a Certificate Program, are primarily focused on legal aspects of the European Union and various legal subject areas (i.e. European Community Law, Human Rights Law, Environmental Law, Competition Law, IPR, etc.) Basic level courses in this subject area, for example, introduce students to the institutional structure of the European Union and the evolution and current framework of the European Treaties. GDUFS courses focus on international relations, EU integration and foreign policy, etc. A number of courses offered by the Asian universities focus on the EU itself structures, history, integration model - as distinct from European culture, history, identity etc. The approach to developing and teaching ES at Jindal Global University encompasses three levels of increasing complexity and depth of knowledge: Foundations of EU, Perspectives about EU, and Concentrations on EU.

One noteworthy observation is that besides courses in the four main thematic areas, there are no courses on research methodology (for example, courses in qualitative methods, quantitative data analyses, and research design.)

The chart below indicates the relative distribution of courses per thematic area.







- 3. **Program/course levels:** Alongside with basic, introductory undergraduate courses and study modules, specialization courses are also offered at partner universities (e.g., the Certificate Program in European Union Legal Studies at SLSP, which is open to both undergraduate and postgraduate students). Most of the undergraduate courses described in this database are offered to second year students and above. Upper-level classes are available to MA and PhD students. At the graduate level, these take the form of seminars on selected topics (i.e. seminar on Sino-EU Hot issues at GDUFS), EU-China, EU-India comparative courses/seminars. Courses vary from compulsory to electives; for example, most of the courses in the GDUFS program are compulsory; therefore if new courses are introduced this would require a longer process of approval and accreditation by the university.
- 4. **Type of instruction**: Most courses are offered in a traditional classroom instruction, and student assessment is based on term papers and examinations. Online formats of instruction are not widely used. In this respect, the project EURASIA has the potential to introduce significant positive change in partner universities. The e-learning platform will offer access to programs and shared course resources not only to faculty and project team members, but also to potential students, thus increasing the attractiveness of each partner university.





- 5. **Teaching staff**: Most of the faculty who teach European Studies courses are senior professors (associate or full professors), as well as junior staff (assistant professors). Some courses are taught by international visiting lecturers, which allow students to gain a different perspective on the topics discussed and to experience various teaching styles. This approach to teaching EU studies may be very beneficial to students who are taking a semester abroad in Europe or applying for mobility/exchange scholarships within Erasmus+.
- 6. Language of instruction: most courses are offered in English; GDUFS offers most of the courses in its current programs in both Chinese and English. The language of instruction also determines the students' choices for exchange/mobility programs in Europe they choose the country according to the language they studied. Given that both BFSU and GDUFS in China have very strong programs in foreign language studies (including Bulgarian, French, Italian, Polish), both the teaching staff and students can take advantage of resources and course materials in ES-related topics and area studies in other European languages besides English.

Conclusions

The database of existing courses and thematic expertise plays a key role not only for assessing the state-of-the-art in the partner countries, but for matching adequately the needs and resources within the EURASIA consortium to produce new knowledge and develop quality EU studies programs. Together with the report on EU-funded projects (deliverable 1.5), this database offers a valuable source of information to other EU studies academics and scholars both in Europe and in Asia.

- **1. Prof. Chen Hanxi** is the director of Center for European Studies. He graduated from Tsinghua University and got PhD degree of International Politics. His research area includes China's diplomacy, security issues of East Asia, etc. He teaches the course of Theory of International Politics.
- **2. Assoc. Prof. Zheng Laxiang**. She was selected by the Academic Committee of the EU-China Higher Education Cooperation Programme, six months fellowship for Chinese scholars at Institute for European Studies of Catholic University of Leuven (Universitécatholique de Louvain) Belgium, UCL.

She got Master of Advanced Studies in European Studies (DEA en Etudes Europeénnes) of Institute for European Studies of University of Geneva (Instituteuropéen de l'université de Genève) Switzerland and Master of Advanced Studies in International Relations (DEA en Relations Internationales) of Graduate Institute of International Studies (Institutuniversitaire de hautesétudes internationals), Switzerland. She got PhD in International Relations of Graduate Institute of International Studies (Institutuniversitaire de hautesétudes internationals).

She studies European integration, China-France relations, and China-EU relations. She teaches the course of the Politics of European Integration.





3. Dr. César de Prado (http://giis.gdufs.edu.cn/info/1208/7492.htm) is an Associate Professor at the Guangdong Institute for International Strategies (GIIS, Guangzhou, China), where he teaches on Europe, Europe-China relations and World Politics, and researches to explain, foresee and strengthen strategic relations between Europe and different parts of Asia. Prof. César de Prado received in 2002 his PhD from the European University Institute (EUI.eu) in Florence with a thesis on Global Political Economy. He went back to the EUI in 2014 as a Distinguished Visiting Scholar in the Global Governance Programme.

In his distinguished academic and professional career he has been a research grantee at the Asia-Europe Comparative Studies Research Project of the Institute of European Studies in Macau, a Fellow or Researcher at the EU-Japan Centre for Industrial Cooperation in Tokyo (Japan), Barcelona Institute of International Studies (Spain), University of Salamanca (Spain), University of Tokyo (Japan), College of Europe — United Nations University in Bruges (Belgium), University of Lund (Sweden), European Commission in Brussels (Belgium), Spanish Embassy's Trade Section in Tokyo (Japan), and KPMG Peat Marwick in Madrid (Spain).

He has single-authored two books (Global Multi-level Governance 2007; Orientate enOriente 1997), co-edited one on Central Asia (2010), and published over 40 academic articles, book chapters and policy papers usually dealing with Europe, Asia and world issues. Some are available through the EUI's Cadmus (http://cadmus.eui.eu) research repository, and others through Dialnet (https://dialnet.unirioja.es/)

His most recent article is "Towards a Substantial EU-Japan Partnership", European Foreign Affairs Review, 22, 4. He is currently drafting articles on EU-China and EU-Asia relations. He can lecture in several European languages and is learning basic Chinese.

4. Dr. Shaohua YAN is assistant professor of European Studies at Guangdong University of Foreign Studies (GDUFS) and research fellow at Guangdong Institute for International Strategies (GIIS). He specializes in EU politics and foreign policy, China-EU relations as well as Hong Kong's external relations. He currently teaches 'EU Politics and Policies' at GDUFS. Before joining the GIIS in 2017, he was Asia Fellow at ESSCA School of Management (Shanghai), co-teaching courses on 'Asian Economy and Geopolitics' as well as 'Country Risk Analysis'. He was visiting researcher at the European Parliament library in Luxembourg and DG External Policies in Brussels in 2014 and 2015 respectively.

Dr. YAN obtained his bachelor's and master's degree in international history from Nankai University in 2007 and 2011. He did a second master of EU International Relations and Diplomacy at the College of Europe in Bruges and was awarded the Inbev-Baillet-Latour Award for the best thesis on EU-China Relations. He got his PhD of European Studies from the University of Hong Kong in 2017.

Dr. YAN has presented and spoken in many international conferences and forums in Asia and Europe. He published a number of articles in peer-reviewed journals and edited volumes, and is a regular contributor to Chinese and international media, including South China





Morning Post, China Daily, the Diplomat, Global Times, the Parliament Magazine, and EurActiv, etc.

5. Dr. Lai Suetyi (**Cher**) is a lecturer and researcher of Centre for European Studies, Guangdong University of Foreign Studies. Before Guangzhou, she was a Post-doctoral Fellow in the Department of International Relations, Tsinghua University (Beijing). Cher finished her doctoral studies in National Centre for Research on Europe, University of Canterbury, in 2012. Her Ph.D thesis focused on the contribution of the ASEM process on Asia-Europe relations, regionalism and inter-regionalism. In order to provide such an understanding, this course will <u>firstly</u> introduce students to the institutional structure of the European Union and the evolution and current framework of the European Treaties. The different roles and functions of the European Parliament, the European Council, the Council of the European Union, the European Commission, and the European Court of Justice will be discussed.

<u>Secondly</u>, the course will introduce and explain the legal principles that are the foundations of European law, such as the hierarchy of sources, the division of competences, the principle of subsidiarity, and the notions of direct effect and supremacy. These principles will be discussed in light of the traditional legal conceptions of the State, of constitutional and international law, and of federalism; this approach will in fact underlie the entire course.

<u>Finally</u>, the second half of the course will provide an analysis of the most important substantive areas of European law, i.e. the customs union, the free movement of goods, services and persons, and competition law, as well as of the EU's ongoing attempts to formulate common policies in other economic fields. It will also look at specific issues that arise due to the particular autonomous status of EU law in the international legal order: most importantly, the EU's relation to the ECHR and its status with respect to general international law and international treaties and conventions will be discussed. Students will obtain an overview of the complex technical issues arising in these areas. Particular emphasis will be given throughout to the role of the European Court of Justice and its interpretive principles
