## Project Summary

The overall objective of the EURASIA project is to introduce high quality European Studies programs in universities in India and China and to enhance the visibility of EU-related topics through the creation of professional academic networks. The project aims to bring positive and long-term impact to higher education institutions in India and China through concerted and focused capacity-building for faculty and staff. EURASIA is a unique initiative with a significant potential to strengthen the international cooperation and dialogue between the European partners and the higher education institutions in India and China.

## Project Objectives

The EURASIA project aims to achieve the following objectives:

1. To contribute to capacity building in India and China in the field of European studies that can effectively enhance the EU-India and EU-China cooperation and dialogue as articulated in the 2016 EU Global Strategy in a Globalizing World.
2. To respond to partner institutions' needs for new education and training modules in European studies and to improve already established BA and MA level programs in EU related subjects.

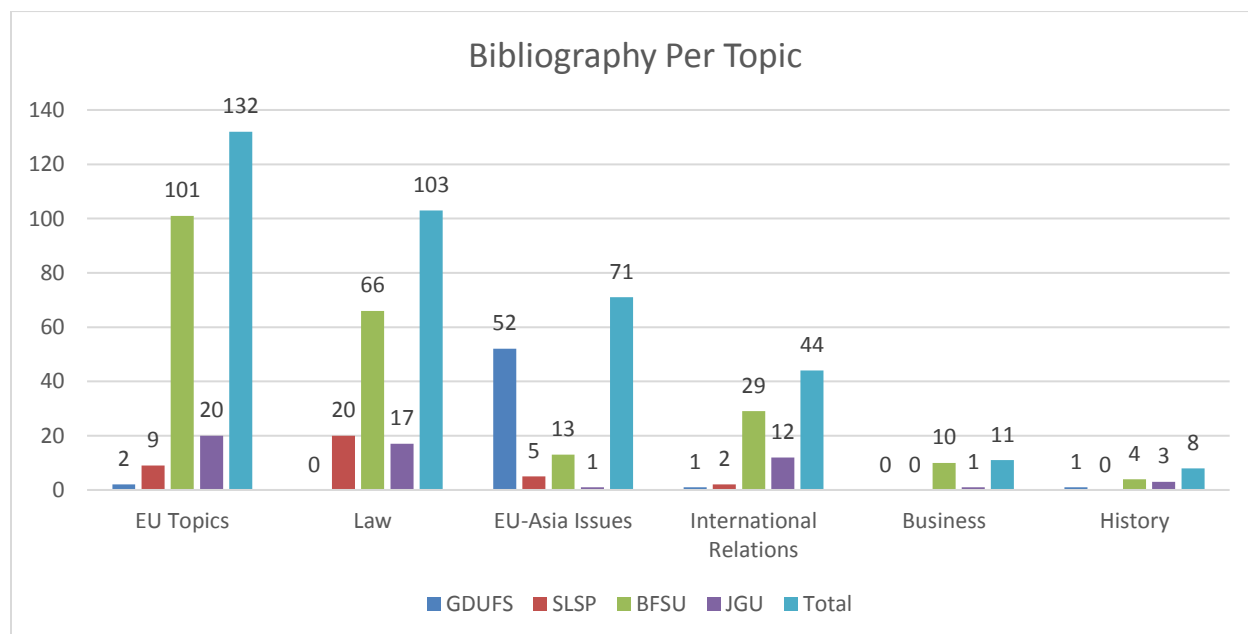

## DOCUMENT DESCRIPTION

This document presents selected titles in the thematic areas of European Studies, European Union, EU-China/EU-India relations available at partner universities in India and China. Collecting information about the available literature is part of the overall needs and gaps analysis planned under WP Preparation. The aim is to provide an up-to-date picture of the primary and secondary sources at the disposal of the Chinese and Indian faculty members in developing their courses. Access to the latest studies published is a major prerequisite for delivering high-quality programs to students and conducting state-of-the-art research by faculty and young scholars. The bibliographical reference tool will become part of the pool of resources available to project partners; it will be updated on a regular basis, and electronic publications and e-books will be shared on the online course platform. They can be used by faculty members in developing the new courses and programs, designing course packs and reading lists for students.

The available titles cover a variety of topics related to the EU history, legal framework, economic policies, EU integration process and international relations, etc. in multiple languages (Chinese, English). The following chart indicates the relative distribution of bibliographical references per topic available at each partner university (overlaps are possible as titles on history may relate to history of EU integration, law, etc.).

The project partners have not reported of any specific procedures in place that lecturers need to follow in choosing requires readings and supplemental literature. Symbiosis Law School-Pune reports that faculty and students have access to multiple e-resources especially pertinent to law such as: Lexis Nexis, Lexis Nexis Practical Guidance, Westlaw, Hein Online, JSTOR, Kluwer International, Cambridge Books Online, Oxford Scholarship Online and multiple Indian databases like Manupatra, SCC Online, EBSCO legal connection, Taxman, Index to Legal periodicals etc. Some of the most widely used databases and e-resources to which the University's faculty, students and staff refer in the process of teaching/learning European Studies include Europa.eu, Online journal packages, Lexis-Nexis newspaper archive. There are also many free e-resources that provide access to completed doctoral theses, articles, cases etc. These sources also provide analytical tools to analyze cases, judgments on various parameters. SLSP is in the process of becoming a member of WorldCat as well. In terms of selecting readings for the courses offered, the literature is selected on the basis of the following parameters, a) relevance to the course topic, b) publisher / author, c) learning outcomes that are mentioned in our detailed session plan for each course (based on levels with respect to Bloom's taxonomy, and d) the focus of the book on EU and India comparison.

The other partner universities do not indicate a particular system or methodology involved in the choice of literature made available to the students and staff. The generalized practice is that teachers are asked ahead of each semester by the library staff about acquisitions of relevant books for the courses they teach or subscriptions to pertinent scholarly databases.

An important observation is the fact that there are no titles on pedagogies or teaching methodologies for European studies programs. There is no mention of any handbooks or toolkits with simulations, games or other teaching techniques. In this respect, the European partners can be very helpful by providing their Asian colleagues a wealth of literature on this subject. The Chinese and Indian faculty who will be developing and teaching courses under EURASIA will have access to more databases and e-resources used also by their European colleagues (JSTOR, T&F online, etc.) as well as to shared resources via teaching platforms such as Moodle. Given that the Chinese universities have a strong background in language teaching and area studies, they may consider acquiring and using course readings in other languages than English (German, French, etc.). This may attract more students to the ES program tracks and, in addition, offer opportunities to design and offer course specifically linked to issues of EU integration and multilingualism (in which partner TLS, for example, has a very strong expertise).



Most of the titles are monographs or edited volumes, published in the past fifteen years. None of the partners mention any official documents (regulations, directives, or policy documents) issued by the EC and its other EU institutions.

The information was provided by project partners using the template in Annex II and is reproduced below. In order to enable searching for specific titles or authors, we have decided to export all of the information in spreadsheet as well.
