You will learn about the intercultural interaction between actors, organisations and institutions from different countries and cultures.







# Students have to register at eurasiaproject.eu and create an account.

#### For groups of students with a mentor/teacher

When redirected back to the EURASIA nanodegree webpage, you have to select the course assigned by your teacher /mentor, then click on the button **Apply for a course as part of a group** and follow the on-screen instructions. When prompted to do so, you have to enter the code you have received from your mentor/teacher.

#### For individual students
